# 1. NOW THIS INDENTURE WITNESSETH AS FOLLOWS:

That, in order to effectuate his aforesaid desire, the Settler has set a part and handed over to the Trustees a sum of Rs.1000/- Rupees One Thousand (hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part therof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

- 1. The Trustees shall keep true and accurate accounts to be kept of all money received and spend and of all matters in respect thereof in course of management of Trust properties or in relation to the carrying out of the objects and purposes of the Trust as well as of all assets, credits and effects of the Trust properties.
- 2. The furtherance of the objects of the Trust and in accordance with the provisions of the Income Tax Act, for the investment or use of Trust Funds, for the time being in force, the Trustee will have the following powers:
  - a) To accept any donation, congribution, loan grant or subscription in cash or kin kind from any person, body or personal body of pesons or trust, with or without conditions.
  - b) To apply the whole or part of the income of the Trust Fund or accumulation thereof or whole or part of the Trust Fund to any one or more of the objects of the Trust as the Trustees may in their discretion from time to time determine.
  - c) To convert and deal with the Trust property and / or to carry the investments for the time being.
  - d) To borrow or raise or secure payments of money and also to lend money either with or without security.
  - e) To sell, dispose of alienate or otherwise deal with any property comprising the Trust Fund To Let-out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretin may think fit.

### 6. PATRONS:

The governing body may according to such terms and conditions as it shall decide from time to time admit as patrons those persons who are likely to help in furthering the objective and causes of the trust either through their professional knowledge and experience and / or through financial assistance.

## 7. TRUSTEES:

7.1. All persons who have attained 18 years of age and have subscribed to the aims and objects of the Trust subject to the approval of the Governing Body will be entitled to

be its Trustees. The decision of the Governing Body in this regard shall be final and

binding.

- 7.2. The Trustees will not be entitled to receive any profit, but the Trustees may receive honorarium/salaries and reimburse all expenses actually incurred by them in connection with their duties relating to Trust.
- 7.3 The Trustees shall be accountable only for such moneys, and funds, which will actually come into their hands.

# 8. TERMINATION OF MEMBERSHIP OF TRUSTEE:

- 8.1. On death
- 8.2. On written resignation
- 8.3. On unsound mind
- 8.4. If found to ge involved in any anti social activities
- 8.5. If found guilty by means of anti propaganda of the Aims and Objects of the Trust
- 8.6. If has not attended three consecutive meeting of the Governing Body without information
- 8.7. If he is requested to resign by 2/3rd or as near there to possible of the remaing Trustees.
- 9. The benefits of the Trust are open to all citizens of India irrespective of caste, creed, race, colour, religion, sex, etc.

## 10. MANAGING TRUSTEE

Chennupati Srikanth shall be designated as the Managing Trustee (President) of the trust. He will be at liberty for the time being to appoint additional trustee within the number mentioned above for such period or on such terms as to retirement and reappointment as the Trustees for the time being consider proper.

# 11. MEETINGS

- 11.1. The governmening body will be held, at least once in four months, notice of such meeting being given at least 15 days in advance. Decision will be taken as far as possible by consensus and in the event of any difference by majority where the votes are equal; the Chairman will have casting vote.
- 11.2. The meeting of the Governing body shall be held at such time and place as the Chairman may decide from time to time and all the meeting of the Governing Body shall be president over by the Chairman and in his absence by any one of the trustees. The should general meeting shall be held not later than six months after the closing of the

## 12. ACCOUNTS

## 12.1. Audit of Accounts:

A Chartered Accountant shall audit the accounts of the trust/society every year.

## 12.2. OPERATION OF BANK ACCOUNT

The Governing body have power to open account in the name of Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by and agent appointed by the Trustees.

## 12.3 SETTLEMENT OF ACCOUNT:

The Governing Body will settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any losss occasioned thereby.

# 13. POWERS AND FUNCTION OF OFFICE BEARER:

### PRESIDENT:

- President shall preside over all the meeting of the trust and have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.
- II. President shall make disbursement in accordance with the direction of Governing Body and shall maintain accounts books minute register and manage daily routine correspondence.
- III. At the time of voting on any matter/subject if the total votes of the group of members happen to be equal in number; the President will have casting vote to dedide the matter/subject.
- IV. President shall preside over all the meeting of the society
- V. At the time of voting on any matter/subject (except election) if the total votes of the group of members happen to be equal in number; the Chairman has tghe power to cast an extra vote to decide the matter/subject.

President shall have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding /meeting



- VII. President shall be convener of all the meetings and without his/her signature on the notice of meetings no meeting will be valid. It shall be his/her duty to see that the resolution at the respective meeting is implemented and given effect timely.
- VIII. President shall be at liberty to spend for the purpose of the Society without sanction of the Managing Committee and to do all such other lawful things as incidental or conducive and expendient to the Society.
- IX. While purchasing or acquiring any movable or immovable property on behalf of NGO the President will sign along with secretary.
- X. In case of resignation of the President. It will be addressed to Secretary

# XI. Irrevobalitity:

It is declared that the trus is irrevocable. If the Trust fails for any reason, in the opinion of the Trustees, the net assets of the Trust both movable and immovable shall be handed over to any other Trust having the sam objects as decided by the Founder/ Chairman Managing Trustee and with the prior permission of the Commissioner of Income Tax.

XII. The Bank Accounts shall be operated by the Founder / Chairman to receive the funds and to credit the same in the Banks as welll as, if necessary to withdrow the same. If necessary to pledge the property. The Founder / Chairman is having full and absolute rights upon the trust, either to develop the Trust or to dissolve the trust or to transfer the trust to any other trust, further the Founder / Chairman and the Vice Chairman is having either to amend the members or to change to bank operations and to collect the subcriptions etc., Except this Corpus Fund this Trust has no movable or immovable propreties as on this deat. In witness whereof the Founder/ Chairman and author of the Trust as here unto set his hand on this 08th Monday of August, 2022.

XIII. Except Corpur fund they are no movable or immovable on this trust name.

### SECRETARY:

The Secretary shall enjoy all the powers of President in his/her Absence.

Secretary will prepare the Membership Register as well as the Proceeding Register to record the minute of the proceedings of the Governing Body Meetings and

have them duly claned by the members who attend the meetings

II. Secretary shall make disburement in accordance with the direction of Governing Body.

# FINANCE EXECUTIVE (Treasurer):

- Treasurer shall maintain the accounts books and all money, which is received and/or paid by him/her on behalf of the trust.
- II. Treasurer shall make disbursement in accordance with the direction of Governing Body.

# 14. FINANCIAL YEAR:

The financial yera of the trust shall be from 1st April to March 31st of every year.

# 15. POWER TO SUE:

The trust may sue or ge sued in the name of the President and secretary

# 16. RECORD:

The Governing Body will maintain a record of Investment and disbursements besides a Minutes Book recording all resolutions and proceedings for every meeting duly confirmed at next meeting and attested by the Chairman of the next meeting.

# 17. COMMITTEES:

Trust can permit its beneficiaries t elect committee or committees from among themselves for the smooth and efficient running of any particular branch of its activities. They can form rules and regulations for that particular branch under the given condition.

### 18. TRUST FUND:

- 18.1 That the trust fund may be augmented by the income from the fund and also by donations and other contribution from time to time.
- 18.2 That the trust fund shall not be applied for any purpose other than those specified in Para 5 herein above unless the other objects added to the trust objectives.
- 18.3. That the Trustees shall always maintain proper books of accounts which shall be kept at the office of the trust.
- 18.4. In the matter of investment of Trust funds, the provision of section 20 of the Indian Trust Act shall apply.

# POWER AND FUNCTION OF THE GOVERNING BODY:

- The Governing Body of the Trust will be empowered to open administrative office, 19.2. regional office, branch offices and central office of the trust in different states of India.
- To administer and cotrol the affairs and funds of the Trust and exercise all power 19.3. of the Trust in order to carry out the aims and objects of the Trust and manage all the institutions established by the Trust.
- To purchase take on lease or in exchange or hire or othewise acquire any movable 19.4. or immovable property for the purpose of the Trust and to carry out agreement, loan, grants and other assistance in suitable terms.
- To provide grant in-aid and other financial assistance to voluntary organization 19.5. and work as link between NGO's working in different parts of India and donor agencies and individual donors.
- 19.6. To accept any donation, contribution, grant-in-aid, subscription in cash or in kind from any person, body persons, trust, foundations, Govt. Departments or Fundding agencies with or without conditions.
- To apply the whole or any part of the income of the trust, or the trust fund or 19.7. accumulations there to any one or more of the objects of the trust, as the trustees may in their discretion deem fit from time to time.
- 19.8. To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- 19.9. To take over, acquire, manage, control or amalgamate with any Institution having object either wholly or in part similar to the object of this Trust and on such terms and conditions as may be thought expendient.
- 19.10 To join, co-operate or amalgamate this trust with other or others having allied objects upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and 1. Jakan: nature of this Trust.

- 19.11. To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and / or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- 19.12. To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise to different charitable institutions, societies organizations or Trusts in India which may have been estableished or which may hereinafter be established for the like charitable purpose.
- 19.13 To grant loan to institutions or persons either on interest or without interest on such terms and conditions as trustees may in their absolute discretion think fit and set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund.
- 19.14. To apply for grant-in-aid or donation to the Govenment Departments and Funding Agencies and to accept grants, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.
- 19.15. The Governing Body shall meet as often as necessary but as least once in every calendar quarter at such place and time as the Managing Trustee may decide. He will send the notice and agenda of these meetings to all members of the Governing Body at least fifteen days before the date fixed for the meeting. The quorum for the meeting shall be one third subject to minimum two trustees.
- 19.16. Whenever the Managing Trustee is of the opinion that a special meeting of the Governing Body is to be called to discuss and decide an urgent matter or shorter duration the Managing Trustee and any one of the trustees will form sufficient quorum and they may take necessary decisions on behalf of the Governeing Body in such emergency meeting.
- 19.17. The Governing Body shall have the power to determine in case of doubt whether

any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses to be paid provided that nothing cantained shall be deemed to Trustee to spend the income or corpus of the trust for any purpose not authorized by these presents.

- 19.18. To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- 19.19. To borrow moneys either on the security of any property comprised in the Trust Fund or othewise for all or any of the purpose of these presents, and it shall be lawful for the trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

## 20. DISSOLUTION:

In the Event of Dissolution of the Trust, the entier Society funds shall be realized and first be used for payment of liabilities of the trust. The assets left if any, shall be disbursed, after obtaining prior approval of the commissioner of Income-Tax (Exemption) New Delhi to other Trust having similar objectives and who have been granted registration u/s 12AA of the Income Tax Act 1961. In no circumstances it shall be distrubuted in any manner to any member of the Trust or thier relatives or related concerns.

## 21. AMENDMENT:

Amendment can be done with the majority of governing body except Trust objects.

This Trust is Movable.

# 22. SEAL OF THE TRUST:

Whenever the seal of the Trust is to be affixed to any writing deed or document

executed by the Trust the same shall be affixed in the presence of persons executing the document. The seal of the Trust shall not be affixed except under the authority of a resolution of the Governing Body.
